MTN DEW® DEW NATION REWARDS PROGRAM TERMS AND OFFICIAL RULES

1. Program Period: Mtn Dew “DEW NATION Rewards” program (the “Program”) begins February 26, 2018 at 12:00 p.m. ET and ends December 31, 2018 11:59 p.m. ET (the “Program Period”) unless otherwise extended by Sponsor (as defined below) in its sole discretion. For the purposes of these program terms and official rules (“Official Rules”), a “day” is defined as a twenty-four (24) hour time period beginning at 12:00 a.m. ET and ending at 11:59 p.m. ET, except for the first day of the program which will be from 12:00 p.m. ET and end at 11:59 p.m. ET on February 26, 2018.

2. Register On-Line: Go to www.dewnationrewards.com (the “Website”) and follow the on-screen instructions to register for the Program or if you’ve already registered sign-in. Use your valid e-mail address along with a complete, valid name, zip code, password, and date of birth to set up your free Program account (“Account”). If you are not an existing Account holder, follow the instructions to register for the Program. If you’ve already registered for the Promotion or already registered for the Mtn Dew DEWNATION rewards program (“DEWNATION Rewards”), you can just sign-in to your Account (“Account” shall mean the Account associated with this Program and any supplemental rewards. Every individual consumer participant (“Participant”) will be required to register on the Website. The Program and any supplemental rewards programs may have their own program terms and the Participant will have to agree to each before being able to participate.

3. How to participate: Buy any 20oz, 16oz, 16.9oz, 1-Liter, 1.5-Liter, and 1.25L and 2-Liter bottles, 16oz or 24oz can, 12oz cans in 12-pack, 15-pack, 18-pack, 20-pack, 24-pack, 30-pack and 36-pack Cartons, 16.9oz or 16oz bottles in, 6-pack, 8-pack, 12-pack, and 24-pack, 7.5oz can in 6, 8, 10, and 15-pack cartons of participating Mtn Dew products. Participating products include: Mtn Dew, Diet Mtn Dew®, Mtn Dew Code Red®, Mtn Dew Game Fuel®, Mtn Dew Live Wire®, Mtn Dew White Out® and Mountain Dew Voltage®, Mtn Dew Baja Blast™, MTN DEW ICE™, Cans of Mtn Dew® Kickstart™, Mtn Dew® Black Label® and Mtn Dew® White Label™ in 12 oz, 16 oz, 16oz 4-packs and 12oz and 16oz 12-packs (“Participating Products”) during the Program Period. Not all products/packages are available in all areas.

Scan or take a picture and upload your eligible original cash register receipt (“Receipt”) to your Account and receive the corresponding points associated with each Participating Product and package size purchased (“Points”):

From time to time, Sponsor may allow retail account specific programs to offer bonus point opportunities based on specific products purchased, dates purchased or other promotional offers. Details for any such account specific programs will be posted on the Website.

In order for your Receipt to be eligible and to receive the Points associated with it, the Receipt must include the store name, time & date of purchase and has to specify the Participating Products purchased. Participating Products must be purchased by an individual Participant and cannot be for products purchased from bottler or distributor for resale. **Participants may upload only up to three (3) Receipts per day per Account** regardless of whether you are participating in this Program or any supplemental rewards program. No handwritten Receipts will be accepted. Once your eligible Receipt has been uploaded to your Account and verified, your Account will be credited with Points that can be redeemed for BTB Rewards (as defined below) or merchandise available from DEWNATION Rewards.
